Please send completed application form with 5–6 images of work (printed on letter sized paper ONLY) with descriptions and price ranges of items. **DO NOT** send any original artwork – applications will not be returned. **DO NOT** send images and application forms separately. Incomplete submissions will not be accepted.

Upon receipt of your application you will receive a message to the email address you have indicated below to notify you that your submission was received. If you do not receive this email, please email bazaart@avam.org or call 410-244-1900 x 243 prior to 7/31/25 to confirm receipt of application. Any applications received after postmark 7/31/25 WILL NOT be considered.

Applications are reviewed and selected by a juried panel. All applicants will be notified in mid-August via email whether or not they have been chosen to participate in Bazaart 2025. Please note: The jury does not provide feedback for each individual artist as to why their work was or was not accepted for Bazaart.

The booth fee for those selected as artists for Bazaart is 200 for a 10x10 booth space with table and access to electric, both available upon request. **DO NOT** send money with this application.
